MASH 2022 Summit Unveils Grants and Training Senator John F. Keenan Accepts Charles Yetman Leadership Award

The MASH Owner/Operator Summit of 2022 focused on five key areas--The Fire Sprinkler Grant, The Probation Grant, The Parole Grant, the Rental Assistance Grant, 3.0 Training, and Development Committee Updates.

The First Annual Charles Yetman Leadership Award was presented to Senator John F. Keenan for his hard work in securing \$4 million to upgrade fire sprinkler systems in sober homes across Massachusetts. MASH will be on hand for our membership to guide them through the funding application process.

Participants were informed on how to take advantage of key state grants only open to certified sober homes in the Commonwealth. Presenters included Michael Coehlo, Deputy Commissioner of Programs at Massachusetts Probation Services, and Kevin Keefe, Executive Director of the Massachusetts Parole Board.

During the dinner, MASH attendees were also updated by Nicole O'Brien, MASH Training Coordinator on new training opportunities in 2022. Development Committee Chairman, Paul Thomas, made a special presentation on his committee's progress.

"MASH sober homes in Massachusetts are saving lives," said Senator Keenan in his remarks. "I am your friend in the Senate and my door is open to your homeowners and operators," said Keenan.

MASH certified sober homes in attendance will receive a \$50.00 discount on their recertification as a token of MASH's appreciation for attending the 2022 Summit.
