MASH ALLOCATES \$1.8 MILLION IN FUNDING FOR OUR CERTIFIED SOBER HOMES AND RESIDENTS

The MASH Rental Assistance Program came into existence about 2 years ago in an effort to provide financial relief to needy applicants seeking sober living. Simultaneously, the MASH Probation/Parole Grant was established to help people who have had contact with probation or that are currently incarcerated and being released under the conditions of Parole

To date, more than **\$935,000** in funds have been disbursed to our Certified Sober Homes under the MASH Probation/Parole Grant, with an additional **\$300,000** in funding remaining for this fiscal year's allocation. We are currently negotiating an extension of this Grant.

In addition, **\$580,000** in funds have been disbursed to our Certified Sober Homes under the Rental Assistance Program. Are advocacy program is currently seeking more funding for Rental Assistance and MASH Scholarships.

We are so proud of the Success these programs have had in helping our Certified Sober Homes and the population we serve. Participation is limited ONLY to MASH Certified Sober Homes in good standing.
